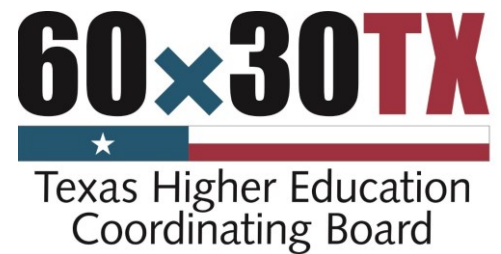


# National Student Clearinghouse Data Files Documentation for ERC



February 2017

## Data Description

The National Student Clearinghouse (NSC) data files contain information on students who have either a Texas Education Agency (TEA) graduation record from 2011 to 2015 and were successfully matched to NSC data from out-of-state institutions and in-state institutions who do not report to THECB. Not all colleges and universities report to the NSC. Researchers who are interested in Texas public IHE enrollment or enrollment at one of the Independent Colleges and Universities of Texas (ICUT) should use the CBM001 data.

In addition, some students request that a college not release their student-level information, so those students' records will not be included in this file. Colleges and universities may also choose to opt out of providing certain types of information; in which case, those data fields will not be populated.

## Notes

- NSC data that will not be represented in tables: Your Unique Identifier, Requester Return Field, Record Found, Search Date, College Code/Branch, 2-year/4-year, Public/Private
  - The search date used for Texas high school graduates was the graduation year + 0601
  - The search date used for all Texas college enrollments was 20080901
- Some found NSC records only contained graduation information and did not provide a period of enrollment. These students will only be found in the graduation file.
- Only high school graduates from 2011 through 2015 have complete cohort data. Other high school graduate cohort years did not have all graduates tracked into NSC data.
- High school graduation year and campus were added to IHE files for only students with a valid SSN in CBM files.
- There are duplicates in files for high school graduates between 2010 and 2015, especially if student applied to a Texas public university. ERC users should use ID2 to de-duplicate files.
- When tracking students within K12 data, ERC users should use ID1. For tracking students into higher education, ID2 should be used.
